Subject: American Virtual Cloud Technologies, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: AVCT1

American Virtual Cloud Technologies, Inc. options were adjusted on October 3, 2022 (See OCC Information Memo #51108).

The new deliverable became 1) 6 American Virtual Cloud Technologies, Inc. (AVCT) Common Shares, and 2) Cash in lieu of approximately 0.6667 fractional AVCT shares. Only settlement of the cash portion of AVCT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.60 per whole AVCT share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$4.60 = \$3.07 \text{ per AVCT1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of October 3, 2022 through October 25, 2022, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the AVCT1 options are as follows:

Per Contract:**

- 1) 6 American Virtual Cloud Technologies, Inc. (AVCT) Common Shares
- 2) \$3.07 Cash

Strike Prices: Unchanged

CUSIP: AVCT: 030382204

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The AVCT component of AVCT1 exercise/assignment activity from October 3, 2022 through October 24, 2022, has settled through National Security Clearing Corporation (NSCC). The \$3.07 cash amount will be settled by OCC.

Pricing

The underlying price for AVCT1 will be determined as follows:

$$\text{AVCT1} = 0.06 (\text{AVCT}) + 0.0307$$

For example, if AVCT closes at 1.41, the AVCT1 price would be calculated as follows:

$$\text{AVCT1} = 0.06 (1.41) + 0.0307 = 0.12$$
