Various ETNs which are part of the Aktiebolaget Svensk Exportkredit Medium-Term Note Program reached maturity on October 24, 2022. The last trading day for the affected ETNs, including the ELEMENTS Linked to the Rogers International Commodity Index - Agriculture Total Return (RJA) ETN, was October 21, 2022.

RJA was suspended from trading on the New York Stock Exchange before the open on October 24, 2022, and RJA holders will receive a cash payment amount calculated as described in the Pricing Supplement No. 23 to Prospectus Supplement and Prospectus dated November 3, 2017 ("Payment at Maturity") per RJA ETN held.

The Payment at Maturity amount has been determined to be \$9.1992 per RJA ETN.

**Contract Adjustment**

The option symbol RJA will not change.

**New Deliverable  
Per Contract:** \$919.92 Cash (\$9.1992 x 100)

RJA options, which were subject to delayed settlement on October 24, 2022, will no longer be subject to delayed settlement, effective October 25, 2022.

Settlement in the RJA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of ELEMENTS Linked to the Rogers International Commodity Index - Agriculture Total Return options whose expiration dates are after 11-18-2022 will have their expiration dates advanced to 11-18-2022. Expiration dates occurring before 11-18-2022 (e.g., Flex options) will remain unchanged.

All ELEMENTS Linked to the Rogers International Commodity Index - Agriculture Total Return options will utilize a \$.01 exercise threshold.

Option Symbol: RJA  
Existing Expiration: All months  
New expiration date: 11-18-2022

Existing American-style ELEMENTS Linked to the Rogers International Commodity Index - Agriculture Total Return options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
