On November 1, 2022, Shareholders of StoneMor Inc. (STON) voted concerning the proposed merger with wholly-owned subsidiary of Axar Cemetery Parent Corporation, a subsidiary of Axar Capital Management, LP. The merger was approved and subsequently consummated on November 3, 2022. As a result, each existing STON Common Share will be converted into the right to receive \$3.50 net cash per share.

Settlement in STON options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of StoneMor Inc. options whose expiration dates are after 11-18-2022 will have their expiration dates advanced to 11-18-2022. Expiration dates occurring before 11-18-2022 (e.g., Flex options) will remain unchanged.

All StoneMor Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 11-18-2022

Existing American-style StoneMor Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
