On October 21, 2022, Benessere Capital Acquisition Corporation (BENE) announced it will redeem all its outstanding Class A Common Shares at a per-share redemption price ("Redemption Amount") of approximately \$10.45.

BENE shares were suspended from trading on NASDAQ before the open on November 1, 2022. As of the close of business on October 31, 2022, each BENE share will be converted into the right to receive the Redemption Amount.

The Redemption Amount has been determined to be \$10.47394209 per BENE share.

## Contract Adjustment

The option symbol BENE will not change.

BENE options, which were subject to delayed settlement from November 1, 2022 through November 3, 2022, will no longer be subject to delayed settlement, effective November 4, 2022.

Settlement in BENE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types. All series of Benessere Capital Acquisition Corporation options whose expiration dates are after 11-18-2022 will have their expiration dates advanced to 11-18-2022. Expiration dates occurring before 11-18-2022 (e.g., Flex options) will remain unchanged.

All Benessere Capital Acquisition Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: BENE Existing Expiration: All months New expiration date: 11-18-2022

Existing American-style Benessere Capital Acquisition Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
