On October 13, 2022, Pine Island Acquisition Corporation (PIPP) announced it will redeem all its outstanding Class A Common Shares at a per-share redemption price (“Redemption Amount”) of approximately \$10.04.

PIPP shares ceased trading on the New York Stock Exchange as of the close of business on October 27, 2022. As of the close of business on October 28, 2022, each PIPP share was converted into the right to receive the Redemption Amount.

The Redemption Amount has been determined to be \$10.05475896 per PIPP share.

**Contract Adjustment**

The option symbol PIPP will not change.

**Date:** October 28, 2022

**New Deliverable**

**Per Contract:** \$1,005.48 Cash (100 x \$10.05475896)

PIPP options, which were subject to delayed settlement from October 28, 2022 through November 9, 2022, will no longer be subject to delayed settlement, effective November 10, 2022.

Settlement in PIPP options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Pine Island Acquisition Corporation options whose expiration dates are after 11-18-2022 will have their expiration dates advanced to 11-18-2022. Expiration dates occurring before 11-18-2022 (e.g., Flex options) will remain unchanged.

All Pine Island Acquisition Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: PIPP

Existing Expiration: All months

New expiration date: 11-18-2022

Existing American-style Pine Island Acquisition Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
