Delayed Settlement

OCC will delay settlement of the cash portion of the FNF1 deliverable until the cash in lieu of fractional FG Common Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

Fidelity National Financial, Inc. (FNF) has announced a distribution of (New) F&G Annuities & Life, Inc. (FG) Common Shares. The distribution ratio is 0.068 of an FG share for each FNF share held. The record date is November 22, 2022; the payable date is December 1, 2022. The NYSE has set December 1, 2022, as the ex-distribution date for this distribution.

F&G Annuities & Life, Inc. Common Shares will begin trading on a when issued basis on November 21, 2022 on the NYSE under the trading symbol "FG WI".
