GoHealth, Inc. (GOCO) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each GOCO Class A Common Share will be converted into the right to receive approximately 0.066666667 (New) GoHealth, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on November 18, 2022. Cash will be paid in lieu of fractional shares.

## **Delayed Settlement**

The GOCO component of the GOCO1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the GOCO1 deliverable until the cash in lieu of fractional GOCO shares amount is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
