Ebang International Holdings Inc. (EBON) has announced a 1-for-30 reverse stock split. As a result of the reverse stock split, each EBON Class A Ordinary Share will be converted into the right to receive 0.033333333 (New) Ebang International Holdings Inc. Class A Ordinary Shares. The reverse stock split will become effective before the market open on November 22, 2022. **Cash will be paid in lieu of fractional shares.**

Until the cash in lieu amount is determined, the underlying price for EBON1 will be determined as follows:

EBON1 = 0.033333333 (EBON)

Delayed Settlement

The EBON component of the EBON deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the EBON1 deliverable until the cash in lieu of fractional EBON shares amount is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
