On November 21, 2022, Omega Acquisition, Inc., an entity wholly owned by Harold G. Hamm, completed its tender offer for Continental Resources, Inc. (CLR). The subsequent merger was consummated on November 22, 2022. As a result, each existing CLR Common Share will be converted into the right to receive \$74.28 net cash per share.

Per Contract:** \$7,428.00 Cash (\$74.28 x 100)

Settlement in CLR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Continental Resources, Inc. options whose expiration dates are after 12-16-2022 will have their expiration dates advanced to 12-16-2022. Expiration dates occurring before 12-16-2022 (e.g., Flex options) will remain unchanged.

All Continental Resources, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 12-16-2022

Existing American-style Continental Resources, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
