On November 29, 2022, Kearny Acquisition Corporation, a wholly-owned subsidiary of Eli Lilly and Company, completed its tender offer for Akouos, Inc. (AKUS). The subsequent merger was consummated before the open on December 1, 2022. As a result, each existing AKUS Common Share will be converted into the right to receive \$12.50 net cash per share plus one non-transferable Contingent Value Right (CVR) per share.

NOTE: The CVR represents a non-transferable contractual right to receive an additional payment as described in the offer. **AKUS options will not be adjusted to call for the delivery of the CVRs.**

Contract Adjustment

Date: December 1, 2022

**New Deliverable
Per Contract:** \$1,250.00 Cash (\$12.50 x 100)

Settlement in AKUS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Akouos, Inc. options whose expiration dates are after 12-16-2022 will have their expiration dates advanced to 12-16-2022. Expiration dates occurring before 12-16-2022 (e.g., Flex options) will remain unchanged.

All Akouos, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 12-16-2022

Existing American-style Akouos, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
