Subject: Adjusted Eloxx Pharmaceuticals, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: ELOX1

Adjusted Eloxx Pharmaceuticals, Inc. options were adjusted on December 2, 2022 (See OCC Information Memo #51467). The new deliverable became 1) 2 Eloxx Pharmaceuticals, Inc. (ELOX) Common Shares, and 2) Cash in lieu of 0.5 fractional ELOX shares. Only settlement of the cash portion of ELOX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$3.47 per whole ELOX share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$3.47 = \$1.74 \text{ per ELOX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of December 2, 2022 through December 15, 2022, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ELOX1 options are as follows:

New Deliverable

Per Contract: 1) 2 Eloxx Pharmaceuticals, Inc. (ELOX) Common Shares
2) \$1.74 Cash

Strike Prices: Unchanged

CUSIP: ELOX: 29014R202

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The ELOX component of ELOX1 exercise/assignment activity from December 2, 2022 through December 14, 2022, has settled through National Security Clearing Corporation (NSCC). The \$1.74 cash amount will be settled by OCC.

Pricing

The underlying price for ELOX1 will be determined as follows:

$$\text{ELOX1} = 0.02 (\text{ELOX}) + 0.0174$$

For example, if ELOX closes at 2.50, the ELOX1 price would be calculated as follows:

$$\text{ELOX1} = 0.02 (2.50) + 0.0174 = 0.07$$
