Global X Education ETF (EDUT) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each EDUT Share will be converted into the right to receive approximately 0.333333 (New) Global X Education ETF Shares. The reverse stock split will become effective before the market open on December 20, 2022. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The EDUT component of the EDUT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the EDUT1 deliverable until the cash in lieu of fractional EDUT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
