On December 1, 2022, Altimeter Growth Corporation 2 (AGCB) announced it will redeem all its outstanding Class A Ordinary Shares at a per-share redemption price ("Redemption Amount") of approximately \$10.11.

AGCB shares were suspended from trading on the New York Stock Exchange before the open on December 21, 2022. **As of the close of business on December 21, 2022, each AGCB share will be converted into the right to receive the Redemption Amount of \$10.11724276.**

**Contract Adjustment**

The option symbol AGCB will not change.

**Date:** December 21, 2022

**New Deliverable**  
**Per Contract:** \$1,011.72 Cash (\$10.11724276 x 100)

Settlement in AGCB options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Altimeter Growth Corporation 2 options whose expiration dates are after 01-20-2023 will have their expiration dates advanced to 01-20-2023. Expiration dates occurring before 01-20-2023 (e.g., Flex options) will remain unchanged.

All Altimeter Growth Corporation 2 options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 01-20-2023

Existing American-style Altimeter Growth Corporation 2 options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
