On December 12, 2022, Shareholders of KKR Acquisition Holdings I Corporation (KAHC) approved a proposed amendment to its Amended and Restated Certificate of Incorporation to allow KAHC to redeem its KAHC shares to holders prior to the original termination date. The amended termination date is December 23, 2022.

KAHC shares were suspended from trading on the New York Stock Exchange before the open on December 15, 2022 and began trading OTC. **As of the close of business on December 23, 2022, each KAHC share will be converted into the right to receive the Redemption Amount of \$10.08285308.**

#### **Contract Adjustment**

The option symbol KAHC will not change.

**New Deliverable**  
**Per Contract:** \$1,008.29 Cash ( $\$10.08285308 \times 100$ )

Settlement in KAHC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of KKR Acquisition Holdings I Corporation options whose expiration dates are after 01-20-2023 will have their expiration dates advanced to 01-20-2023. Expiration dates occurring before 01-20-2023 (e.g., Flex options) will remain unchanged.

All KKR Acquisition Holdings I Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: KAHC

Existing Expiration: All months

New expiration date: 01-20-2023

Existing American-style KKR Acquisition Holdings I Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
