On December 27, 2022, Shareholders of USHG Acquisition Corporation (HUGS) approved a proposed amendment to its Second Amended and Restated Certificate of Incorporation to allow HUGS to redeem its shares to holders prior to the original termination date. As a result, HUGS shares will be suspended from trading on the New York Stock Exchange before the open on December 28, 2022.

Each HUGS Class A Common Share will be converted into the right to receive the Redemption Amount ("Redemption Amount") of approximately \$10.10.

Contract Adjustment

The option symbol HUGS will not change.

**New Deliverable
Per Contract:** Approximately \$1,010.00 Cash (\$10.10 x 100)

Settlement: HUGS options will be subject to delayed settlement effective December 28, 2022 until the final Redemption Amount is determined.

Once the final deliverable is determined, settlement in HUGS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
