On December 27, 2022, Shareholders of Poshmark, Inc. (POSH) voted concerning the proposed merger with Proton Parent, Inc., a wholly-owned subsidiary of NAVER Corporation. The merger was approved and subsequently consummated before the open on January 5, 2023. As a result, each existing POSH Class A Common Share will be converted into the right to receive \$17.90 net cash per share.

**Contract Adjustment**

**Date:** January 5, 2023

**New Deliverable**  
**Per Contract:** \$1,790.00 Cash ( $\$17.90 \times 100$ )

Settlement in POSH options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Poshmark, Inc. options whose expiration dates are after 01-20-2023 will have their expiration dates advanced to 01-20-2023. Expiration dates occurring before 01-20-2023 (e.g., Flex options) will remain unchanged.

All Poshmark, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 01-20-2023

Existing American-style Poshmark, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
