Subject: Adjusted NantHealth, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: NH1

Adjusted NantHealth, Inc. options were adjusted on December 16, 2022 (See OCC Information Memo #51576). The new deliverable became 1) 6 NantHealth, Inc. (NH) Common Shares, and 2) Cash in lieu of 0.6666667 fractional NH Shares. Only settlement of the cash portion of NH1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.21 per whole NH share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.6666667 \times \$4.21 = \$2.81 \text{ per NH1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of December 16, 2022 through January 05, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NH1 options are as follows:

New Deliverable

Per Contract: 1) 6 NantHealth, Inc. (NH) Common Shares
2) \$2.81 Cash

Strike Prices: Unchanged

CUSIP: NH: 630104305

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The NH component of NH1 exercise/assignment activity from December 16, 2022 through January 4, 2023, has settled through National Security Clearing Corporation (NSCC). The \$2.81 cash amount will be settled by OCC.

Pricing

The underlying price for NH1 will be determined as follows:

$$\text{NH1} = 0.06 (\text{NH}) + 0.0281$$

For example, if NH closes at 3.95, the NH1 price would be calculated as follows:

$$\text{NH1} = 0.06 (3.95) + 0.0281 = 0.27$$
