On December 27, 2022, Shareholders of USHG Acquisition Corporation (HUGS) approved a proposed amendment to its Second Amended and Restated Certificate of Incorporation to allow HUGS to redeem its shares to holders prior to the original termination date. As a result, HUGS shares were suspended from trading on the New York Stock Exchange before the open on December 28, 2022.

Each HUGS Class A Common Share will be converted into the right to receive the Redemption Amount ("Redemption Amount") of \$10.1172495959.

Contract Adjustment

The option symbol HUGS will not change.

New Deliverable
Per Contract: \$1,011.72 Cash (\$10.1172495959 x 100)

HUGS options, which were subject to delayed settlement from December 28, 2022 through January 9, 2023, are no longer subject to delayed settlement, effective January 10, 2023.

Settlement in HUGS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of USHG Acquisition Corporation options whose expiration dates are after 01-20-2023 will have their expiration dates advanced to 01-20-2023. Expiration dates occurring before 01-20-2023 (e.g., Flex options) will remain unchanged.

All USHG Acquisition Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: HUGS

Existing Expiration: All months

New expiration date: 01-20-2023

Existing American-style USHG Acquisition Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
