On January 31, 2023, Shareholders of O2Micro International Limited (OIIM) will vote concerning the proposed merger with Rim Peak Technology Limited, a wholly-owned subsidiary of FNOF Precious Honour Limited. If the merger is approved and consummated, each existing OIIM American Depositary Share will be converted into the right to receive \$5.00 net cash per share, less fees (including \$0.02 cash distribution fee, less \$0.05 ADS cancellation fee) and withholdings, if any.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the first quarter of 2023.

New Deliverable
Per Contract: \$500.00 Cash (\$5.00 x 100), less fees and withholdings, if any

Settlement in OIIM options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
