Subject: Adjusted New York City REIT, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: NYC1

Adjusted New York City REIT, Inc. options were adjusted on January 12, 2023 (See OCC Information Memo #51707. The new deliverable became 1) 12 New York City REIT, Inc. (NYC) Class A Common Shares, and 2) Cash in lieu of 0.5 fractional NYC shares. Only settlement of the cash portion of NYC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$13.25 per whole NYC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$13.25 = \$6.63 \text{ per NYC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 12, 2023 through January 19, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NYC1 options are as follows:

New Deliverable

Per Contract: 1) 12 New York City REIT, Inc. (NYC) Class A Common Shares
2) \$6.63 Cash

Strike Prices: Unchanged

CUSIP: NYC: 649439304

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The NYC component of NYC1 exercise/assignment activity from January 12, 2023 through January 18, 2023, has settled through National Security Clearing Corporation (NSCC). The \$6.63 cash amount will be settled by OCC.

Pricing

The underlying price for NYC1 will be determined as follows:

$$\text{NYC1} = 0.12 (\text{NYC}) + 0.0663$$

For example, if NYC closes at 14.25, the NYC1 price would be calculated as follows:

$$\text{NYC1} = 0.12 (14.25) + 0.0663 = 1.78$$
