Jaguar Health, Inc. (JAGX) has announced a 1-for-75 reverse stock split. As a result of the reverse stock split, each JAGX Common Shares will be converted into the right to receive approximately 0.013333 (New) Jaguar Health, Inc. Common Shares. The reverse stock split will become effective before the market open on January 23, 2023. Cash will be paid in lieu of fractional shares.

Until the cash in lieu amount is determined, the underlying price for JAGX1 will be determined as follows:

$$\text{JAGX1} = 0.013333 (\text{JAGX})$$

Delayed Settlement

The JAGX component of the JAGX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the JAGX1 deliverable until the cash in lieu of fractional JAGX Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
