Subject: Epiphany Technology Acquisition Corporation – Redemption/Cash Settlement/Acceleration of Expirations Option Symbol: EPHY Date: 01/13/2023

On December 16, 2022, Epiphany Technology Acquisition Corporation (EPHY) announced it will redeem all its outstanding Class A Common Shares at a per-share redemption price ("Redemption Amount") of approximately \$10.10. EPHY shares were suspended from trading on Nasdaq before the open on January 13, 2023.

Each EPHY Class A Common share will be converted into the right to receive the Redemption Amount of \$10.07715572.

Contract Adjustment

The option symbol EPHY will not change.

EPHY options, which were subject to delayed settlement from January 13, 2023 through January 20, 2023, are no longer subject to delayed settlement, effective January 23, 2023.

Settlement in EPHY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Epiphany Technology Acquisition Corporation options whose expiration dates are after 02-17-2023 will have their expiration dates advanced to 02-17-2023. Expiration dates occurring before 02-17-2023 (e.g., Flex options) will remain unchanged.

All Epiphany Technology Acquisition Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: EPHY Existing Expiration: All months New expiration date: 02-17-2023

Existing American-style Epiphany Technology Acquisition Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
