On October 18, 2022, Shareholders of Micro Focus International plc (MFGP) voted concerning the proposed Scheme of Arrangement with Open Text UK Holding Limited, a wholly-owned subsidiary of Open Text Corporation. The scheme was approved and subsequently consummated before the open on January 31, 2023. **As a result, each existing MFGP American Depositary Share will be converted into the right to receive the US Dollars equivalent of 532 Pence Sterling, less depositary fees and expenses, which has been determined to be \$6.425504 (\$6.475504 less \$0.05 cancellation fee).**

Contract Adjustment

PER CONTRACT:** \$642.55 Cash (\$6.425504 x 100)

MFGP options, which were subject to delayed settlement from January 31, 2023 through February 17, 2023, are no longer subject to delayed settlement, effective February 21, 2023.

Settlement in MFGP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Micro Focus International plc options whose expiration dates are after 03-17-2023 will have their expiration dates advanced to 03-17-2023. Expiration dates occurring before 03-17-2023 (e.g., Flex options) will remain unchanged.

All Micro Focus International plc options will utilize a \$.01 exercise threshold.

Existing American-style Micro Focus International plc options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
