Adjusted CarLotz, Inc. (LOTZ) options were adjusted on December 9, 2022 (See OCC Information Memo #51551). The new deliverable became 1) 71 Shift Technologies, Inc. (SFT) Class A Common Shares.

Shift Technologies, Inc. (SFT) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each SFT Class A Common Share will be converted into the right to receive 0.1 (New) Shift Technologies, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on March 8, 2023. Cash will be paid in lieu of fractional SFT shares.

Until the cash in lieu amount is determined, the underlying price for SFT1 will be determined as follows:

SFT1 = 0.071 (SFT)

### **Delayed Settlement**

The SFT component of the SFT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SFT1 deliverable until the cash in lieu of fractional SFT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
