Cloopen Group Holding Limited (RAAS) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each RAAS American Depositary Share will be converted into the right to receive approximately 0.333333 (New) Cloopen Group Holding Limited American Depositary Shares. The reverse stock split will become effective before the market open on March 15, 2023. Cash will be paid in lieu of RAAS fractional shares.

The RAAS component of the RAAS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the RAAS1 deliverable until the cash in lieu of fractional RAAS Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
