On March 29, 2023, Shareholders of Volta Inc. (VLTA) will vote concerning the proposed merger with SEV Subsidiary, Inc., a wholly-owned subsidiary of Shell USA, Inc. If the merger is approved and consummated, each existing VLTA Common Shares will be converted into the right to receive \$0.86 net cash per share.

Contract Adjustment

Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the first half of 2023.

New DeliverablePer Contract:\$86.00 Cash (\$0.86 x 100)

Settlement in VLTA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations
