On February 24, 2023, Far Peak Acquisition Corporation (FPAC) announced it will redeem all its outstanding Class A Ordinary Shares at a per-share redemption price ("Redemption Amount") of approximately \$10.21. FPAC shares were suspended from trading on the New York Stock Exchange before the open on March 8, 2023. The redemption date was March 13, 2023.

The final Redemption Amount has been confirmed to be \$10.21514065.

Contract Adjustment

The option symbol FPAC will not change.

New Deliverable

Per Contract: \$1,021.51 Cash (\$10.21514065 x 100)

FPAC options, which were subject to delayed settlement from March 8, 2023 through March 13, 2023, will no longer be subject to delayed settlement, effective March 14, 2023.

Settlement in FPAC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Far Peak Acquisition Corporation options whose expiration dates are after 04-21-2023 will have their expiration dates advanced to 04-21-2023. Expiration dates occurring before 04-21-2023 (e.g., Flex options) will remain unchanged.

All Far Peak Acquisition Corporation options will utilize a \$.01 exercise threshold.

Existing American-style Far Peak Acquisition Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
