## Subject: Umpqua Holdings Corporation - Cash In Lieu Settlement Adjusted Option Symbol: COLB1

Umpqua Holdings Corporation options were adjusted on March 1, 2023 (See OCC Information Memo #52032). The new deliverable became 1) 59 Columbia Banking System, Inc. (COLB) Common Shares, and 2) Cash in lieu of 0.58 fractional COLB Common Shares. Only settlement of the cash portion of COLB1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$30.47 per whole COLB share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.58 x \$30.47 = \$17.67 per COLB1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 1, 2023 through March 20, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the COLB1 options are as follows:

## <u>Settlement</u>

The COLB component of COLB1 exercise/assignment activity from March 1, 2023 through March 17, 2023, has settled through National Security Clearing Corporation (NSCC). The \$17.67 cash amount will be settled by OCC.

## **Pricing**

The underlying price for COLB1 will be determined as follows:

COLB1 = 0.59 (COLB) + 0.1767

For example, if COLB closes at 21.20, the COLB1 price would be calculated as follows:

COLB1 = 0.59 (21.20) + 0.1767 = 12.68
