Redhill Biopharma Ltd. (RDHL) has announced a 1-for-40 reverse stock split. As a result of the reverse stock split, each RDHL American Depositary Share will be converted into the right to receive 0.025 (New) Redhill Biopharma Ltd. American Depositary Shares. The reverse stock split will become effective before the market open on March 23, 2023. BNY Mellon, the depositary, will attempt to sell any fractional ADSs and distribute the cash proceeds to ADR holders.

Delayed Settlement

The RDHL component of the RDHL1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the RDHL1 deliverable until the cash in lieu of fractional RDHL Shares, if any, is determined. Upon determination of the cash in lieu amount, if any, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
