Subject: Adjusted Redhill Biopharma Ltd. – Cash In Lieu Settlement

Adjusted Option Symbol: RDHL1

Adjusted Redhill Biopharma Ltd. options were adjusted on March 23, 2023 (See OCC Information Memo #52155). The new deliverable became 1) 2 Redhill Biopharma Ltd. (RDHL) American Depositary Shares and 2) Cash in lieu of 0.50 fractional RDHL shares. Only settlement of the cash portion of RDHL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.83 per whole RDHL share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.50 \times 4.83 = 2.42 \text{ per RDHL1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 23, 2023 through March 29, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the RDHL1 options are as follows:

New Deliverable

Per Contract: 1) 2 Redhill Biopharma Ltd. (RDHL) American Depositary Shares

2) \$2.42 Cash

Strike Prices: Unchanged

CUSIP: RDHL: 757468202

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The RDHL component of RDHL1 exercise/assignment activity from March 23, 2023 through March 28, 2023, has settled through National Security Clearing Corporation (NSCC). The \$2.42 cash amount will be settled by OCC.

Pricing

The underlying price for RDHL1 will be determined as follows:

$$RDHL1 = 0.02 (RDHL) + 0.0242$$

For example, if RDHL closes at 4.84, the RDHL1 price would be calculated as follows:

$$RDHL1 = 0.02 (4.84) + 0.0242 = 0.12$$
