## Subject: IAA, Inc. – Cash In Lieu Settlement Adjusted Option Symbol: RBA1

IAA, Inc. options were adjusted on March 21, 2023 (See OCC Information Memo #52139). The new deliverable became 1) 52 Ritchie Bros. Auctioneers Incorporated (RBA) Common Shares, 2) Cash in lieu of 0.52 fractional RBA shares, and 3) \$1,280.00 cash. Only settlement of the cash portion of RBA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$53.50 per whole RBA share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.52 x \$53.50 = \$27.82 per RBA1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 21, 2023 through March 29, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the RBA1 options are as follows:

New Deliverable Per Contract:	1) 52 Ritchie Bros. Auctioneers Incorporated (RBA) Common Shares 2) \$1,307.82 Cash (\$1,280.00 + \$27.82)
Strike Prices:	Unchanged
CUSIP:	RBA: 767744105
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

## **Settlement**

The RBA component of RBA1 exercise/assignment activity from March 21, 2023 through March 28, 2023, has settled through National Security Clearing Corporation (NSCC). The \$1,307.82 cash amount will be settled by OCC.

## **Pricing**

The underlying price for RBA1 will be determined as follows:

RBA1 = 0.52 (RBA) + 13.0782

For example, if RBA closes at 55.52, the RBA1 price would be calculated as follows:

RBA1 = 0.52 (55.52) + 13.0782 = 41.95
