On January 23, 2023, Invesco Exchange-Traded Fund Trust II announced it will liquidate and terminate Invesco Russell 1000 Low Beta Equal Weight ETF (USLB) on or about April 6, 2023. The last day of trading for USLB shares on NASDAQ is **March 30, 2023**.

Shareholders who do not sell their USLB shares before market close on March 30, 2023 will receive cash equal to the amount of the net asset value of their shares on or about April 6, 2023.

Contract Adjustment

The option symbol USLB will not change.

**New Deliverable
Per Contract:** 100 x the cash amount equal to the net asset value per Invesco Russell 1000 Low Beta Equal Weight ETF (USLB) share, less any applicable transaction costs, pursuant to the liquidation

Note: The determination to include any distributions, if any, in the contract adjustment will be made by OCC on a case-by-case basis.

Settlement: USLB options will be subject to delayed settlement beginning March 31, 2023, until the pro rata cash proceeds amount paid to USLB Shareholders pursuant to the liquidation is determined.

Once the final cash amount to be included in the USLB deliverable is determined, settlement in USLB options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
