On May 20, 2021, Shareholders of Shaw Communications Inc. (SJR) voted concerning the proposed plan of arrangement with Rogers Communications Inc. The plan of arrangement was approved and subsequently consummated on April 3, 2023. As a result, each existing SJR Class B Non-Voting Participating Share will be converted into the right to receive 40.50 CAD net cash per share. **The final net cash merger consideration in USD has been confirmed to be \$29.87591536 per share.**

Contract Adjustment

New Deliverable
Per Contract: \$2,987.59 Cash ($\29.87591536×100)

SJR options, which were subject to delayed settlement from April 4, 2023 through April 10, 2023, are no longer subject to delayed settlement, effective April 11, 2023.

Settlement in SJR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Shaw Communications Inc. options whose expiration dates are after 4-21-2023 will have their expiration dates advanced to 4-21-2023. Expiration dates occurring before 4-21-2023 (e.g., Flex options) will remain unchanged.

All Shaw Communications Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Shaw Communications Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
