On March 29, 2023, Shareholders of Atlas Technical Consultants, Inc. (ATCX) voted concerning the proposed merger with a wholly-owned direct subsidiary of GI Apple Midco LLC, which is controlled by investment funds advised by GI Manager L.P. The merger was approved and subsequently consummated before the open on April 19, 2023. As a result, each existing ATCX Class A Common Share will be converted into the right to receive \$12.25 net cash per share.

**Contract Adjustment**

**New Deliverable  
Per Contract:** \$1,225.00 Cash (\$12.25 x 100)

Settlement in ATCX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Atlas Technical Consultants, Inc. options whose expiration dates are after 05-19-2023 will have their expiration dates advanced to 05-19-2023. Expiration dates occurring before 05-19-2023 (e.g., Flex options) will remain unchanged.

All Atlas Technical Consultants, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 05-19-2023

Existing American-style Atlas Technical Consultants, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
