 Horizon Acquisition Corporation II – Redemption/Cash Settlement/Acceleration of Expirations Option Symbol: HZON Date: 04/26/2023

On April 11, 2023, Horizon Acquisition Corporation II (HZON) announced it will redeem all its outstanding Class A Ordinary Shares at a per-share redemption price ("Redemption Amount") of approximately \$11.33. HZON shares were suspended from trading on the New York Stock Exchange before the open on April 26, 2023, and each HZON share was converted into the right to receive the Redemption Amount.

The final Redemption Amount has been confirmed to be \$11.3283042 per share.

Contract Adjustment

The option symbol HZON will not change.

HZON options, which were subject to delayed settlement on April 26, 2023, are no longer subject to delayed settlement, effective April 27, 2023.

Settlement in HZON options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Horizon Acquisition Corporation II options whose expiration dates are after 05-19-2023 will have their expiration dates advanced to 05-19-2023. Expiration dates occurring before 05-19-2023 (e.g., Flex options) will remain unchanged.

All Horizon Acquisition Corporation II options will utilize a \$.01 exercise threshold.

Option Symbol: HZON Existing Expiration: All months New expiration date: 05-19-2023

Existing American-style Horizon Acquisition Corporation II options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
