Subject: Adjusted MoneyLion Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: ML1

Adjusted MoneyLion Inc. options were adjusted on April 25, 2023 (See OCC Information Memo #52305). The new deliverable became 1) 3 MoneyLion Inc. (ML) Class A Common Shares and 2) cash in lieu of approximately 0.3333 fractional ML Shares. Only settlement of the cash portion of ML1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$10.986 per whole ML share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.333 \times \$10.986 = \$3.66 \text{ per ML1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 25, 2023 through May 08, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ML1 options are as follows:

New Deliverable

Per Contract: 1) 3 MoneyLion Inc. (ML) Class A Common Shares
2) \$3.66 Cash

Strike Prices: Unchanged

CUSIP: ML: 60938K304

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The ML component of ML1 exercise/assignment activity from April 25, 2023 through May 5, 2023, has settled through National Security Clearing Corporation (NSCC). The \$3.66 cash amount will be settled by OCC.

Pricing

The underlying price for ML1 will be determined as follows:

$$ML1 = 0.03 (ML) + 0.0366$$

For example, if ML closes at 13.14, the ML1 price would be calculated as follows:

$$ML1 = 0.03 (13.14) + 0.0366 = 0.43$$
