Adjusted Exela Technologies, Inc. (XELA) options (adjusted option symbol XELA1) were adjusted on July 26, 2022 (See OCC Information Memo #50776). The new deliverable became 1) 5 Exela Technologies, Inc. (XELA) Common Shares.

Exela Technologies, Inc. (XELA) has announced a 1-for-200 reverse stock split. As a result of the reverse stock split, each XELA Common Share will be converted into the right to receive 0.005 (New) Exela Technologies, Inc. Common Shares. The reverse stock split will become effective before the market open on May 15, 2023. Cash will be paid in lieu of fractional shares.

$$\text{XELA1} = 0.00025 (\text{XELA})$$

## **Delayed Settlement**

OCC will delay settlement of the cash portion of the XELA1 deliverable until the cash in lieu of fractional XELA Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
