Ault Alliance, Inc. (AULT) has announced a 1-for-300 reverse stock split. As a result of the reverse stock split, each AULT Common Share will be converted into the right to receive approximately 0.003333 (New) Ault Alliance, Inc. Common Shares. The reverse stock split will become effective before the market open on May 18, 2023. Cash will be paid in lieu of fractional shares.

OCC will delay settlement of the cash portion of the AULT1 deliverable until the cash in lieu of fractional AULT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
