Adjustment/Acceleration of Expirations

Adjusted American Virtual Cloud Technologies, Inc. options were adjusted on October 3, 2022 (See OCC Information Memo #51234). The new deliverable became 1) 6 American Virtual Cloud Technologies, Inc. (AVCTQ) Common Shares, and 2) \$3.07 Cash.

On May 23, 2023, the United States Bankruptcy Court for the District of Delaware confirmed the Debtors' Combined Disclosure Statement and Chapter 11 Plan of Liquidation ("Plan") for American Virtual Cloud Technologies, Inc. (AVCTQ). The Plan became effective on May 30, 2023, and AVCTQ shares were canceled.

Adjusted AVCT1 options will be further adjusted to reflect the bankruptcy as described below:

## **Contract Adjustment**

Effective May 30, 2023, existing AVCT1 options are further adjusted to no longer call for the delivery of AVCTQ shares upon exercise.

The option symbol AVCT1 will not change.

New Deliverable

Per Contract: \$3.07 Cash

Settlement in ACVT1 options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types. All series of American Virtual Cloud Technologies, Inc. options whose expiration dates are after 6-16-2023 will have their expiration dates advanced to 6-16-2023. Expiration dates occurring before 6-16-2023 (e.g., Flex options) will remain unchanged.

All American Virtual Cloud Technologies, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: AVCT1

Existing Expiration: All months New expiration date: 6-16-2023

Existing American-style American Virtual Cloud Technologies, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
