Blue Apron Holdings, Inc. (APRN) has announced a 1-for-12 reverse stock split. As a result of the reverse stock split, each APRN Class A Common Share will be converted into the right to receive approximately 0.083333 (New) Blue Apron Holdings, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on June 8, 2023. Cash will be paid in lieu of fractional shares.

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for APRN1 will be determined as follows:

$$\text{APRN1} = 0.083333 (\text{APRN})$$

## **Delayed Settlement**

The APRN component of the APRN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the APRN1 deliverable until the cash in lieu of fractional APRN Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
