Local Bounti Corporation (LOCL) has announced a 1-for-13 reverse stock split. As a result of the reverse stock split, each LOCL Common Share will be converted into the right to receive approximately 0.076923 (New) Local Bounti Corporation Common Shares. The reverse stock split will become effective before the market open on June 15, 2023. Cash will be paid in lieu of fractional shares.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for LOCL1 will be determined as follows:

$$\text{LOCL1} = 0.076923 (\text{LOCL})$$

## **Delayed Settlement**

The LOCL component of the LOCL1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the LOCL1 deliverable until the cash in lieu of fractional LOCL Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
