On March 12, 2023, SAP America, Inc., the majority shareholders of Qualtrics International Inc. (XM), which owned approximately 95.9% of outstanding XM shares, delivered a written consent approving the merger agreement with Quartz MergerCo, Inc., a wholly owned subsidiary of Quartz Holdco, LLC. The merger was consummated before the open on June 28, 2023. As a result, each existing XM Class A Common Share will be converted into the right to receive \$18.15 net cash per share.

Settlement in XM options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Qualtrics International Inc. options whose expiration dates are after 07-21-2023 will have their expiration dates advanced to 07-21-2023. Expiration dates occurring before 07-21-2023 (e.g., Flex options) will remain unchanged.

All Qualtrics International Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: XM Existing Expiration: All months New expiration date: 07-21-2023 Existing American-style Qualtrics International Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
