On June 8, 2023, Shareholders of Diversey Holdings, Ltd. (DSEY) voted concerning the proposed merger with affiliates of Platinum Equity, LLC and Solenis LLC. The merger was approved and subsequently consummated on July 5, 2023. As a result, each existing DSEY Ordinary Share will be converted into the right to receive \$8.40 net cash per share.

## Contract Adjustment

New DeliverablePer Contract:\$840.00 Cash (\$8.40 x 100)

Settlement in DSEY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Diversey Holdings, Ltd. options whose expiration dates are after 07-21-2023 will have their expiration dates advanced to 07-21-2023. Expiration dates occurring before 07-21-2023 (e.g., Flex options) will remain unchanged.

All Diversey Holdings, Ltd. options will utilize a \$.01 exercise threshold.

Option Symbol: DSEY Existing Expiration: All months New expiration date: 07-21-2023

Existing American-style Diversey Holdings, Ltd. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
