Subject: Adjusted Shapeways Holdings, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: SHPW1

Adjusted Shapeways Holdings, Inc. options were adjusted on June 23, 2023 (See OCC Information Memo #52711). The new deliverable became 1) 12 Shapeways Holdings, Inc. (SHPW) Common Shares and 2) Cash in lieu of 0.5 fractional SHPW Shares. Only settlement of the cash portion of SHPW1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$3.368 per whole SHPW share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.5 \times 3.368 = 1.68 \text{ per SHPW1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 23, 2023 through July 06, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the SHPW1 options are as follows:

New Deliverable

Per Contract: 1) 12 Shapeways Holdings, Inc. (SHPW) Common Shares

2) \$1.68 Cash

Strike Prices: Unchanged

CUSIP: SHPW: 81947T201

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The SHPW component of SHPW1 exercise/assignment activity from June 23, 2023 through July 5, 2023, has settled through National Security Clearing Corporation (NSCC). The \$1.68 cash amount will be settled by OCC.

Pricing

The underlying price for SHPW1 will be determined as follows:

$$SHPW1 = 0.12 (SHPW) + 0.0168$$

For example, if SHPW closes at 4.06, the SHPW1 price would be calculated as follows:

$$SHPW1 = 0.12 (4.06) + 0.0168 = 0.50$$
