On July 31, 2023, Heisman Merger Sub, Inc., a wholly owned subsidiary of Mr. Cooper Group Inc. completed its tender offer for Home Point Capital Inc. (HMPT). The subsequent merger was consummated before the open on August 1, 2023. As a result, each existing HMPT Common Share will be converted into the right to receive \$2.33 net cash per share.

Per Contract:** \$233.00 Cash (\$2.33 x 100)

Settlement in HMPT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Home Point Capital Inc. options whose expiration dates are after 08-18-2023 will have their expiration dates advanced to 08-18-2023. Expiration dates occurring before 08-18-2023 (e.g., Flex options) will remain unchanged.

All Home Point Capital Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 08-18-2023

Existing American-style Home Point Capital Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
