On September 8, 2023, Shareholders of Amedisys, Inc. (AMED) will vote concerning the proposed merger with Aurora Holdings Merger Sub Inc., a wholly owned subsidiary of UnitedHealth Group Incorporated. If the merger is approved and consummated, each existing AMED Common Share will be converted into the right to receive \$101.00 net cash per share.

## **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.

Contract adjustment is expected to occur in 2024.

New Deliverable

**Per Contract:** \$10,100.00 Cash (\$101.00 x 100)

Settlement in AMED options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
