Subject: Spectrum Pharmaceuticals, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: ASRT1

Spectrum Pharmaceuticals, Inc. options were adjusted on August 1, 2023 (See OCC Information Memo #52950). The new deliverable became 1) 17 Assertio Holdings, Inc. (ASRT) Common Shares, and 2) Cash in lieu of 0.83 fractional ASRT shares. Only settlement of the cash portion of ASRT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.05 per whole ASRT share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.83 \times \$6.05 = \$5.02 \text{ per ASRT1 Contract}$ 

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 1, 2023 through August 17, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ASRT1 options are as follows:

New Deliverable

**Per Contract:** 1) 17 Assertio Holdings, Inc. (ASRT) Common Shares

2) \$5.02 Cash

Strike Prices: Unchanged

**CUSIP:** ASRT: 04546C205

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The ASRT component of ASRT1 exercise/assignment activity from August 1, 2023 through August 16, 2023, has settled through National Security Clearing Corporation (NSCC). The \$5.02 cash amount will be settled by OCC.

## **Pricing**

The underlying price for ASRT1 will be determined as follows:

$$ASRT1 = 0.17 (ASRT) + 0.0502$$

For example, if ASRT closes at 3.23, the ASRT1 price would be calculated as follows:

$$ASRT1 = 0.17 (3.23) + 0.0502 = 0.60$$
