Subject: Adjusted Molecular Templates, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: MTEM1

Adjusted Molecular Templates, Inc. options were adjusted on August 14, 2023 (See OCC Information Memo #53023). The new deliverable became 1) 6 Molecular Templates, Inc. (MTEM) Common Shares and 2) Cash in lieu of approximately 0.6667 fractional MTEM Shares. Only settlement of the cash portion of MTEM1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$9.00 per whole MTEM share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

 $0.6667 \times \$9.00 = \$6.00 \text{ per MTEM1 Contract}$ 

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 14, 2023 through August 21, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the MTEM1 options are as follows:

**New Deliverable** 

**Per Contract:** 1) 6 Molecular Templates, Inc. (MTEM) Common Shares

2) \$6.00 Cash

Strike Prices: Unchanged

**CUSIP:** MTEM: 608550208

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

## Settlement

The MTEM component of MTEM1 exercise/assignment activity from August 14, 2023 through August 18, 2023, has settled through National Security Clearing Corporation (NSCC). The \$6.00 cash amount will be settled by OCC.

## **Pricing**

The underlying price for MTEM1 will be determined as follows:

$$MTEM1 = 0.06 (MTEM) + 0.06$$

For example, if MTEM closes at 9.00, the MTEM1 price would be calculated as follows:

$$MTEM1 = 0.06 (9.00) + 0.06 = 0.60$$
