On September 21, 2023, Shareholders of Reata Pharmaceuticals, Inc. (RETA) will vote concerning the proposed merger with River Acquisition, Inc., a wholly owned subsidiary of Biogen Inc. If the merger is approved and consummated, each existing RETA Class A Common Share will be converted into the right to receive \$172.50 net cash per share.
