Subject: Adjusted AMC Entertainment Holdings, Inc. – Cash In Lieu Settlement
Adjusted Option Symbols: AMC2/1AMC2/2AMC2

Adjusted AMC Entertainment Holdings, Inc. options were adjusted on August 23, 2023 and August 24, 2023. (See OCC Information Memo #53090.) The new deliverable became 1) 11 AMC Entertainment Holdings, Inc. (AMC) Class A Common Shares, and 2) Cash in lieu of approximately 0.3333 fractional AMC shares. Only settlement of the cash portion of AMC2/1AMC2/2AMC2 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$11.2144 per whole AMC share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$11.2144 = \$3.74 \text{ per AMC2/1AMC2/2AMC2 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 23, 2023 through September 06, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the AMC2/1AMC2/2AMC2 options are as follows:

New Deliverable Per Contract: 1) 11 AMC Entertainment Holdings, Inc. (AMC) Class A Common Shares
2) \$3.74 Cash

Strike Prices: Unchanged

CUSIP: AMC: 00165C302

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The AMC component of AMC2/1AMC2/2AMC2 exercise/assignment activity from August 23, 2023 through September 5, 2023, has settled through National Security Clearing Corporation (NSCC). The \$3.74 cash amount will be settled by OCC.

Pricing

The underlying price for AMC2/1AMC2/2AMC2 will be determined as follows:

$$\text{AMC2} = 0.11 (\text{AMC}) + 0.0374$$

For example, if AMC closes at 13.64, the AMC2/1AMC2/2AMC2 price would be calculated as follows:

$$\text{AMC2} = 0.11 (13.64) + 0.0374 = 1.54$$
